Total expenditures for the same period we \$449,369.55. Leaving an end of fund balance February 28, 2019 of \$5,392.007.73. This is an increase of \$156,268.03.

The request for Funding process opened on March 15th Trolian does not anticipate any new applicants or too many deviations from last year's proposals. The Board is still waiting to hear on the SOR Housing grant, which they should hear back on it this week. We are also still waiting one more grant for Peer Support Specialist. The "as introduced" budget from the Governor is out with some increases. April 9, 2019 Trolian and Lamb will testify in front of the Committee. We will be working diligently to maintain the increase through the budget process.

7. Agency Presentation – Richland County NAMI- Mary Kay Pierce and Darlene Reed Darlene was ill and unable to make it. They are cofounders of NAMI in Mansfield. In 1998 they met each other, both having a mentally ill family member, they started Family to Family. Both advocate for families who need help. There starting there 39th class this week, it's a 12-week class. They communicate to the disabled family members. Giving them any and all information they can use and will need to help their loved ones. They just had there 23rd class of CIT training. A total of 505 law enforcement people are trained to know how to react and handle situation that could arise with a mentally ill person. They volunteer at Ohio Health every Tuesday and do a class. NAMI Connections meet at OASIS building (next door to us). Starting another new program called AOT (Assisted Out Patient Treatment).

Trolian said Mansfield's law director doesn't want to arrest if offender has a CCW and is taking
