

On March 15, 2019, the Richland County Mental Health and Recovery Services Board (The Board) is officially opening the request for funding period. Agencies that have not held a contract with The Board in the past may submit a request for funding if they meet all of the following criteria:

- Is certified by the Ohio Department of Mental Health and Addiction Services
- Holds a National Accreditation from one of the following CARF, COA, TJC(JACHO)
- Is registered with the Federal Government and the State of Ohio as a Non-Profit entity
- Is certified to provide Medicaid funded services and has done so for a minimum of three years with no disciplinary actions or suspensions.
- Is able to provide three years of consecutive unqualified audits
- Is able to show or demonstrate that they are providing trauma informed services (i.e. certificate of successful completion from a registered Evidence-Based Program or Completion of the Richland County TIROCC Program in the past three years.

Purchasing of services for SFY 2020, is based on service trends from the 1st half of SFY 2019. The following is the list of General Services that the Board will purchase system wide. Rates will mirror BH Redesign rates. If Interactive Complexity can be applied to a service, it is assumed you are doing so for establishing an allocation. We will be grouping services as presented below for establishing allocations and to give providers the flexibility to move funds around within service groups. However, you will need to report on the MHA UCR 2020 the actual units of each separate service you intend to provide.

BH Redesign Service Types:

Assessment and Evaluation:

- Assessment Non-Physician: **270 Units** (*this includes 90791 MH/AOD Psychiatric Evaluation and H0001 SUD Assessment*)

Counseling and Therapy

- Psychotherapy Individual: **575 Units** (*this includes 90832,34 & 37 MH/AOD Psychotherapy Individuals, +99354 Prolonged service and H0004 SUD Counseling & Therapy*)
- Psychotherapy Group: **75 Units** (*this includes 90853 Psychotherapy group*)
- Group Counseling SUD: **15,000 Units** (*this includes SUD H0005*) *Special note, if billing IOP for Board funding, you will bill in units of H0005, i.e. 3 hours of IOP would be billed as 12 units of H0005)
- Family Psychotherapy: **50 Units** (*this includes 90846, 90847 Family Psychotherapy without or with patient and 90849 Multi-family group psychotherapy*)

Coordination and Support

- Coordination and Support: **10,300 Units** (*this includes H0006 SUD Case Management, H0036 CPST, H2017 Psychosocial Rehab and H2019 TBS*)

Medical and Related

- SUD Collection: **650 Units** (*this includes H0048 SUD Collection and Handling*)

Unless otherwise indicated, the units presented are what the Board would like to purchase in total from the system.

For example; if we are purchasing 1000 units of Individuals Counseling and Therapy, if agency A proposes to provide 400 units, agency B proposes 400 units and agency C proposes 200 units, all will be funded at the proposed level. However, if Agency A proposes to provide 1000, agency B proposes to provide 500 and agency C proposes to provide 500, The board may reduce all to 500/250/250 or choose to just fund agency B and C at their proposed levels.

So please only propose to provide the number of units that can realistically be provide to the indigent population by your organization. We will also compare your proposal to current service trends and adjust accordingly. All services will be provided using the Board Sponsored and Subsidized Services and Sliding Fee Guidelines.

Please note that preference for funding will be given to agencies whose corporate office is located in Richland County.
