

On March 17, 2017 The Richland County Mental Health and Recovery Services Board (The Board) is officially opening the request for funding period. Agencies that have not held a contract with The Board in the past may submit a request for funding if they meet all of the following criteria:

- Is certified by the Ohio Department of Mental Health and Addiction Services
- Holds a National Accreditation from one of the following CARF, COA, TJC(JACHO)
- Is registered with e Federal Government and the State of Ohio as a Non-Profit entity
- Is certified to provide Medicaid funded services and has done so for a minimum of three years with no disciplinary actions or suspensions.
- Is able to provide three years of consecutive unqualified audits
- Is able to show or demonstrate that they are providing trauma informed services (i.e. certificate of successful completion from a registered Evidence-Based Program or Completion of the Richland County TIROCC Program in the past three years.

Purchasing of services for SFY 2018, as discussed at the Pre-Release Bidders meeting on March 9, 2017 will be based on 3 years of analysis and data trends. The following is the list of General Services that the Board will purchase system wide as well as the corresponding rate that will be used to establish the allocation including Interactive Complexity where applicable:

Psychiatric Diagnostic Evaluation w/o Medical:	500 Units (175-SUD/325-MH) \$122.85/Enc
Psychotherapy Individual:	2000 Units (1200-SUD/800-MH) \$65.38/30min
Psychotherapy Group:	500 Units (500-MH) \$33.37/Enc
SUD Group:	3000 Units (3000-SUD) \$7.21/15min
Psychotherapy Individual Family:	1000 Units (500-SUD/500-MH) \$86.95/50min
Psychotherapy Family Group:	500 Units (250-SUD/250-MH) \$26.59/Enc
Coordination and Support Individual:	3000 Units (3000-MH) \$28.59/15 min
Coordination and Support Group:	3000 Units (3000-MH) \$8.99/15 min
SUD Case Management:	500 Units (500-SUD) \$19.54/ 15 min
Lab U/A:	750 Units (750-SUD) \$14.48/Enc

Please note these rates are to establish **Allocations Only**. *For example the allocation for Coordination and Support consists of Therapeutic Behavioral Services H2019, Psychosocial Rehabilitation H2017 and Community Psychiatric Supportive Treatment H0036. The highest possible reimbursement rate is \$28.59 for 15 minutes.* Please base your request on the number of units estimated to be provided times the rate of \$28.59. You will bill the Board for the appropriate BH Redesign code at the established rendering provider rate for that service. Please note that preference for funding will be given to agencies whose corporate office is located in Richland County.
